# New South Wales Fire Brigades Operations Bulletin 2009/06 Bush and grass fires - first informative and sitrep messages



### **Information required**

When bush and grass fires occur, accurate information from the fireground is vital for providing the Incident Controller with the resources required, coordinating joint operations, and issuing accurate and timely warnings and information to the public.

A checklist has been developed showing the information required in first informative and sitrep messages (see page 2).

Incident Controllers *must* use this checklist at bush and grass fires to ensure their messages contain the required information.

### **Bushfire alerts and warning messages**

Information on the type of fire, its status and size, the wind conditions, exposures and evacuations is used to determine the bushfire alert level and issue community warnings. For more information on bushfire alerts and warning messages, see Operations Bulletin 2009/05, *Fire danger ratings and bushfire alert messages*.

The information is also passed on to the Rural Fire Service for inclusion in its incident database and the <u>current incidents page</u> of the Rural Fire Service website so the public can see what is happening.

#### **Sitreps**

In accordance with SOG 2.6, <u>Standard radio messages</u>, Section 6.7, sitreps must be sent at regular intervals. As a guide, they should be sent 5 minutes after the first informative message and then every 15 to 20 minutes.

There is no need to repeat information already transmitted if there has been no change.

Incident Controllers must take into account other agencies' firefighting resources when determining the Alarm Response level in NSWFB Metropolitan areas where the <u>Alarm Response Protocol</u> applies.

## **Bush and Grass Fires First Informative and Sitrep Messages**

- Send first informative messages by radio. Subsequent detailed messages may be given by phone.
- Send sitreps at regular intervals, eg 5 mins after the first informative message and then every 15 to 20 mins.
- Do not repeat information already transmitted if there has been no change.
